In relation with the above object of this Power of Attorney, the faculties inherent to a power are bestowed upon you and in particular those faculties necessary to file required applications and petitions before various authorities and private persons; to authorize with your signature all kinds of documents; to pay fees and taxes as well as to disburse any other necessary expenses; to file oppositions and consents in connection with applications for trademark registrations lodged by third parties, to make limitations and clarifications; to hear, receive and answer all kinds of notifications and to appeal before the corresponding authority be it judicial or administrative; to promote "amparo" suits and to intervene in them as third injured party; to request the voluntary cancellation of registered trademarks; to defend the validity of all kinds of patent and trademark registrations; to promote and to obtain declarations of nullity and extinction of registrations of third parties and of infringements of patents, trademark registrations and of other industrial and intellectual property rights; to file complaints and accusations and to prosecute in whatever manner necessary, infringements of said rights and, in general, to do everything necessary to enforce, preserve and defend such rights, including the authority to fully or partially substitute this power and to confirm all kinds of legal acts previously executed by you and by other proxies in the previously mentioned matters.
